To apply, please submit the following four things either in paper to the Office of Residence Life in Crawford Hall 134 or via e-mail to reslife@morrisville.edu by Wednesday, February 28, 2018 at Noon.

- 1. RA Application—Applicant Information Sheet (attached)
- 2. Résumé
- 3. Cover letter: Please answer ALL of the following questions in your cover letter.
 - From your perspective, what do you think are the most important roles of a Resident Assistant? Please explain.
 - What skills do you possess that you can offer the Residence Life team? Please relate these to the RA position as you understand it.
 - What do you hope to gain here at MSC as an RA and how will this help you accomplish your future goals?
- 4. One recommendation form: Must be completed by an MSC faculty or professional staff member; other than a RD or a RA. Forms are also available on our website <u>http://www.morrisville.edu/studenthousing/forms.aspx</u>

Additional Requirements

- 2.5 cumulative GPA
- Be in good financial and judicial standing.
- Must be a current fulltime Morrisville State College student.
- Must have completed one semester of college prior to the intended semester of employment.
