MANDATORY REQUIREMENTS

Prior to campus arrival all students registered for 6 credit hours or more <u>MUST</u> submit the following:

- 1. Verification of MMR immunity
- 2. Meningococcal Meningitis Vaccine Date or Refusal Letter
- **3. Physical Exam and Health History**
- 4. TuberculosisTesting (if applicable)
- 5. Parental consent for care of minors (if applicable)

Non-compliance may result in dismissal from SUNY Morrisville

NEW YORK STATE LAW: MMR REQUIREMENTS

Records may be located at your previous college, high school or family doctor's office.

In accordance with NYS Law any student born after January 1, 1957, must provide proof of immunity to measles, mumps, and rubella, this requirement may be met by the following: proof of disease, immune titers, or two {2} measles, one {1} mumps, and one {1} rubella vaccine given after the student's first birthday).

NEW YORK STATE LAW: MENINGITIS VACCINE

The Center for Disease Control Advisory committee on Immunization Practices (ACIP) recently issued a new recommendation for college students registered for 6 credit hours or more: Students, especially those living in residence halls, should consider vaccination to reduce their risk for <u>MENINGOCOCCAL DISEASE</u>.

New York State Public Health Law 2167 requires:

- A response to receipt of meningococcal disease and vaccine information signed by the student or student's parent or guardian (if under the age of 18). **AND EITHER**
- A record of at least 1 dose of meningococcal ACWY vaccine within the past 5 years or a complete 2-dose series of MenB; OR
- An acknowledgement of meningococcal disease risks and refusal of meningococcal meningitis immunization waiver signed by the student or student's parent or guardian (if under the age of 18).

PRE-ADMISSION PHYSICAL

All students **MUST** submit proof of having had a physical examination not more than one year prior to the start of their first semester in order to use Student Health Services. This physical exam should preferably be done by your PCP (Primary Care Physician). A one-time courtesy visit will be granted to students not submitting a pre-admission physical. Please note that the Student Health Center does **NOT** perform pre-admission physicals.

TUBERCULOSIS TESTING

Tuberculosis skin testing is **REQUIRED** for all <u>International Students</u>. International students should also complete the Tuberculosis Screening Questionnaire. Students at low risk are not required to undergo tuberculosis skin testing.

HEALTH INSURANCE

All students taking 12 credit hours or more are required by federal law to be covered by health insurance. PLEASE CONTACT YOUR HEALTH INSURANCE CARRIER TO BE SURE YOU ARE COVERED FOR ALL MEDICAL SERVICES WITHIN 50 MILES OF MORRISVILLE STATE COLLEGE. <u>Please note:</u> Students will be charged for the Student Health Insurance unless a waiver form is submitted in Web for Students. If you waive the student health insurance, please be sure to bring your insurance card with you to campus.

PARENTAL CONSENT FOR CARE OF MINORS

If a student is under the age of 18 when starting school, a parental consent to treat must be completed and **SIGNED** in order for the Health Center to provide care.
